General Terms: The City of Durand is requesting bids for street sweeping services for an area of 12 curb miles (#1). This area is described further in the attached route map. Services are expected to commence the week of May 13, 2019 and continue on a schedule of once every two weeks until the week of September 23, 2019. We anticipate this service will be performed approximately ten times during the 2019 calendar year. The City's preference is for these activities to occur on Friday every other week, conditions permitting.

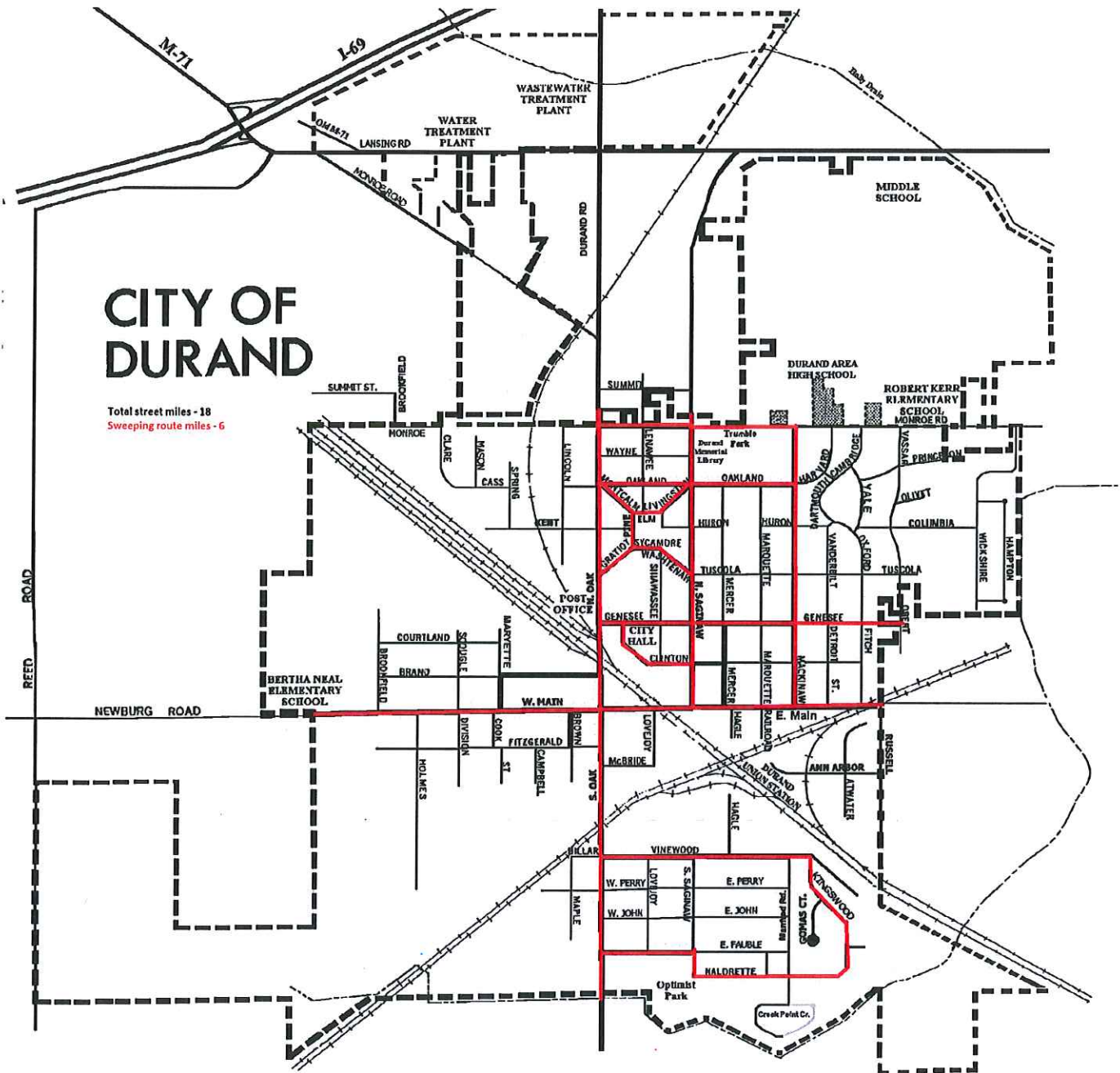
In addition, the City is requesting bids for street sweeping services for an area of 36 curb miles, or all roads within the City of Durand jurisdiction (# 2). Service of this area may be expected to occur one time per year in the spring. If full city sweeping is requested this would be in lieu of the standard sweeping route for a given two week period.

The City will consider a one or a two year commitment. All scheduling will be formalized with the selected contractor prior to contract commencement. Payment should be billed on a per occurrence basis.

The awarded bidder must provide proof of property damage, worker's compensation, and liability insurance in the amount of \$1,000,000.00 (1 million) dollars at the time the contract is executed.
